RETIRED K-9 ASSISTANCE APPLICATION

ELIGIBILITY AND APPLICATION PROCESSING

Eligibility Requirements:

- Owners must be active or retired Military, DOD, Fire/Arson or Law Enforcement Officer and/or a current government-employed K-9 handler to be eligible for participation.
- K-9s that are retired or decommissioned and that served in any DOD, Military, Fire Department or Law Enforcement agency of any state or local governmental authority of the Commonwealth of Virginia or served within the Commonwealth of Virginia are eligible for participation.

Application Processing:

- Applications may be submitted via email to info@k9pd.org or by mail to P.O. Box 411, Chesterfield, VA 23832.
- All official communication will be handled via email. Please provide a valid email address *that is monitored regularly*.
- Applications will not be processed without evidence of retirement from an eligible department/agency and a photograph of the K-9.
- All images and descriptions provided to the VP K-9 Association may be published in our marketing materials and/or posted to our electronic media sites. By providing this information, you agree to its use in our marketing efforts.
- All applications must be approved by the VP K-9 Association board of directors. Processing may take up to 60 days.
